Each Trustee brings their unique perspectives and skills, which helps us represent the needs of the whole community. If you feel the nudge to apply to be a trustee or just want to find out more, please follow that hint from Spirit.

The Board consists of nine trustees, each serving a three-year term, plus our Senior Minister, Dr. Edward Viljoen. Each year three new members are elected to replace the three members who are completing their three-year terms. We are now accepting applications for the three members who will join the Board in March, 2024.

This document outlines the basic position requirements and expectations for board service, the nomination process and election procedures, including key dates, and the application form.

Applying for a Board position is an enriching experience in and of itself. We invite you to take your time and mindfully explore what Board service may mean to you. When you are ready to apply, please complete the questionnaire included in this document. Submission instructions are included in the questionnaire.

Applications will be accepted from September 15 to November 28, 2023.

# **General Information**

#### **Basic Requirements**

In order to be considered for candidacy, applicants must meet the following requirements:

- Minimum one-year membership at the Center for Spiritual Living, Santa Rosa
- Strong foundation in Science of Mind principles and completion of a core class
- Commitment to the Center for Spiritual Living, Santa Rosa
- Ability and availability to give time and talent to the Center
- Contributes financially to the Center with a regular, identifiable record of giving
- Business experience and/or organizational skills
- Ease with long-range planning
- Comfort and facility with attending Zoom video calls

### **Expectations and Commitments**

- Have a computer and email account for frequent Board communications between Trustees
- Serve a three-year term
- Attend Board meetings (usually the fourth Thursday of each month), currently via Zoom
- Attend monthly Conversations sessions with the Senior Minister (usually the fourth Wednesday of each month), in person at the Center.
- Actively contribute to visioning/planning activities
- Maintain visibility and contact with our community
- Communicate with and listen to congregants

### **Nomination Process and Selection Procedures**

To be considered for the 2024-2027 term position, applicants complete and submit their applications by November 28, 2023. The Nominating Committee will review all applications and conduct pre-screening calls as applications are received.

All eligible candidates will be interviewed by a panel consisting of four trustees, a prayer practitioner or minister, and a lay person. Following the interviews, the Committee will recommend a slate of three candidates to the Board of Trustees at the January 2024 Board meeting. The slate will be announced to the congregation in late February 2024 and will be presented to the Center's members at the Annual Membership meeting in March 2024. New Trustees are elected at the Annual Membership meeting, and they then begin their three-year terms.
